Greetings from Resonance!

We are pleased to inform that your ward is completing class XI of the foundation course of this session and is about to be promoted from VIKAAS (JA)/ VIPUL (JB) to VIJETA (JPA/ JPB) in Class XII in the coming session 2024-25. The students in Hindi medium will be similarly promoted to VIJETA (JPH). For all these students, this will be their next step towards success and Resonance has planned the entire year to strengthen the foundation of their success.

Resonance was founded on 11<sup>th</sup> April 2001 with a vision to impart education innovatively. Since then it has been continuously incorporating innovative methods to give the best education to students.

At Resonance, we also started preparing our students for the online mode. In 2018-19 session with the announcement that National Testing Agency (NTA) will be conducting JEE (Main) Examination twice a year on CBT (Computer Based Test) Mode. We were smooth with the change as we had been giving our students the practice of online exams and had proactively adopted the changes required for Online mode of examination. We have online testing labs and made arrangements with private computer labs also where our students take online tests and are offered practice for the core exam.

**“Starting early is the key to success”** and hence we complete the entire syllabus of class XI in a very structured manner. **New batches of Class XII will be commencing from 5<sup>th</sup> February 2024.** By starting session of 12<sup>th</sup> class early, the course will be completed early and students will get more time for revision of boards & JEE (Main) January-2025 attempt.

The students joining class 12<sup>th</sup> batches in January 2024 will be termed as JP. They will be undergoing 2+ months of classes (after depositing 1<sup>st</sup> Installment of the course fee) covering initial topics of class 12<sup>th</sup> curriculum. These students are likely to be benefitted in terms of more time for revision and getting prepared to tune with 12<sup>th</sup> syllabus. However, these topics will be covered in JPA/ JPB batches which will be resuming from 1<sup>st</sup> April 2024. Resonance wishes the very best to your child. Surely, the RESONite would work hard to make a great career.

**Note:** For Students who are depositing the fees in 2 installments, it is mandatory for them to submit a Post Dated Cheque (PDC)/ JODO (resonance.jodo.in) for the 2nd installments at the time of depositing the 1st Installment.

The Rate of GST is decided by Govt. of India and is subject to revision. Hence, the rate/amount of GST may increase/decrease or any other tax may be introduced in the future. The Institute shall pass on the effect of change (increase/decrease/ intro of a new tax) in these rates to students/parents, if any change is announced by the Govt. of India. The students shall be informed at an appropriate time about the same as and when the Govt. of India announces the change.

**4. Benefits of Joining JPA/ JPB:** Since 2013-14 session, we have been following the concept of forming early batches of class-XII students namely JPA/ JPB. This has proved beneficial for our students. Some of the key benefits are as follows:

- 4.1 An early start helps to maintain less class frequency which results in a better understanding of the topics.
- 4.2 Early concepts of class XII get more time which results in an in-depth understanding of the key concepts.
- 4.3 Productive utilization of the free time available to students before their school examinations of class XI.
- 4.4 Easy transition from class XI to class XII and no break in the rhythm of studies.
- 4.5 Because of the early start, we will be able to complete Class-XII syllabus [JEE (Main), Board, JEE (Advanced)] by November 2024 and will get sufficient time for revision session in month of December to appear in January 2024 attempt/ 25 tests in each subject will be conducted between January 2025- April 2025 attempt to fully equip the students for April 2024 attempt, taking care of all the deficiency areas/ Post April 2025 JEE (Main), we will finally collect for quick revision through fresh DPPs, aiming at JEE (Advanced) to revise theory and take Advanced tests (8 tests) and discussions as our best support to students for success in JEE (Advanced) 2025.

**5. How to Deposit Course Fee:** The Course Fee shall be paid to Resonance Eduventures Limited:

- 5.1 Through a Demand Draft or Pay Order made in favour of RESONANCE EDUVENTURES LIMITED and payable at the respective Study Centre of Resonance where the student wishes to enroll for the course. The DD can be deposited in person at any of the Study Centers of Resonance. The student must write his/her Name, Father's Name, Course and Application Form No. on the Back of DD/ Pay order while depositing course fee/ If the student is sending the DD through the post then it should be sent to Kota office by Registered Post /Courier immediately so that it reaches us on or before the last date of fee deposition.
- 5.2 The Fee can also be directly deposited in the SBI Account of Resonance Eduventures Ltd. (30969014861/ IFSC: SBIN0001534) / CBI Account of Resonance Eduventures Ltd. (3154400127)/ HDFC Bank Account of Resonance Eduventures Ltd. (50200016937462) at any of the branches of Banks through Cash or Demand Draft made in favour of Resonance by using Fee Deposition Challan/ The Bank Fee Deposition Challan is available at the Help Desk of Student Zone, CG Tower-1 and can also be downloaded from the website www.resonance.ac.in.
- 5.3 Students who are depositing the fees in 2 or more installments, it is mandatory for them to submit a Post Dated Cheque (PDC)/ JODO (resonance.jodo.in) for the remaining installments at the time of depositing the 1st Installment.

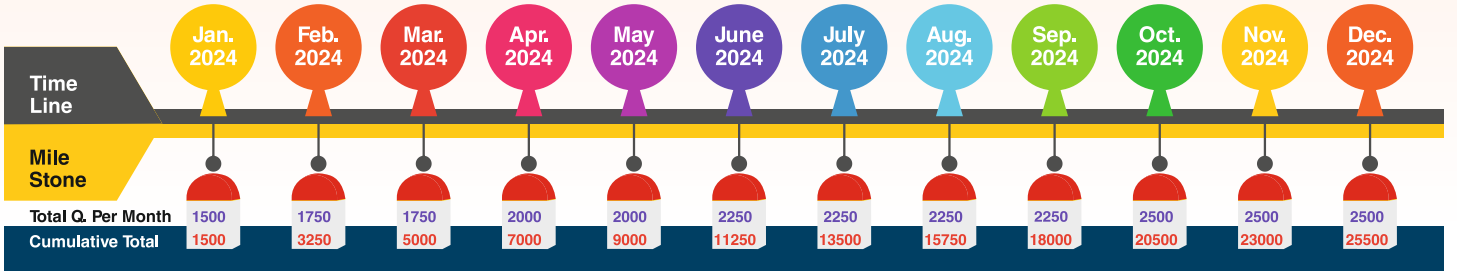
